## **Learner Supervision**

#### 1. Preamble

Tafelberg prides itself on the standard of education and quality of interventions provided to our learners. We wish to maintain and improve in the holistic development of our learners and their well-being and create a safe educational environment.

# 2. Before school (mornings)

- 2.1. Parents must note that the official starting time for school in the morning is 8am. Staff are on duty as from 7:30am onwards.
- 2.2. Parents will, therefore, take responsibility for the safety and security of their children should they drop them off before 7:30am, as the school does not have the manpower nor facilities to care for learners that are dropped off at school before 7:30am. Thus the school will not take responsibility for the safety and security of any learner and or his/her belongings for the period before 7:30am.
- 2.3. The learner gate will be opened at 7:30am.
- 2.4. Should there be a need for assistance or to report an incidence before 7:30am, the learner(s) must report to the main gate intercom for assistance.
- 2.5. The learner gate will be locked at 8:00am sharp.
- 2.6. Learners who are late <u>must</u> enter must wait outside the gate until opened by an educator and report to the secretary before going to their register class.

# 3. During school hours (breaks)

- 3.1. Teachers/therapists and Prefects/RCL members are rostered for break-time duties on the playgrounds each school day.
- 3.2. Teachers / therapists who are absent, will make arrangements for substitutes.
- 3.3. The staff on duty will deal with all playground related incidences as per school policy.

## 4. After school (afternoons):

- 4.1. Tafelberg does not offer an aftercare service due to insufficient staff and facilities, and due to the fact that teachers / therapists have meetings, sport and in-service training after school.
- 4.2. Teachers / therapists will do duty at the learner gate from the time school closes until 3pm Monday to Thursday, and until 2:20pm on Fridays.
- 4.3. Learners must be fetched by their parents at the end of the school day as per times given to all parents, failing which they will accept responsibility for their child's safety and security.

- 4.4. Should parents be late in fetching their child, they need to inform the school before 3pm. The learner will then wait inside the school grounds until they are fetched, however, the school cannot accept responsibility or liability for the learner's safety due to a lack of manpower to supervise the said learner until he/she is fetched.
- 4.5. Learners playing league sports will be dropped at designated points after their match/practice by the coach/school driver, to be picked up by their parents.
- 4.6. Teachers /therapists and prefects/RCL are rostered for afternoon gate duty according to the school end-of-day times supplied to parents and learners.
- 4.7. Staff will be on duty until 3pm, Mondays to Thursdays, and 2:20pm on Fridays. The learner gate will be locked at 3:00pm (Monday-Thursday) and at 2:20pm on Fridays. Learners who are still waiting for their parents to fetch them after 4:30pm will be referred to the SAPS station (on the corner of Swellengrebel Ave), from which the parent can collect their child.

# 5. Outings, camps, tours, dances and sport

- 5.1. The appropriate permission must be gained from Principal/Deputies before any outing etc can be planned and organised.
- 5.2. Once permission is granted, all documents and safety procedures etc must be in force before leaving the school premises.
- 5.3. Teachers accompanying learners must represent the gender composition of the learner group.
- 5.4. There must be minimum of 1 teacher/adult for every 13 learners.
- 5.5. A comprehensive list of learner names must be kept by the tour organiser (teacher), and be used for roll-call.

This policy shall be known as the **LEARNER SUPERVISION POLICY**

The school governing body may from time to time amend, supplement, modify or alter this policy.
